

2. School shall comply with the provisions of DSEAR, 1973, RTE Act, 2009 and directions/instructions/guidelines issued by the Department from time to time and pronouncement w.r.t. maintenance / utilization of schools funds.
3. The school shall comply with the provisions of Rule 176, 177 and Section 18(5), 17(3) & order dated 15.12.1999, 10.05.2005, 11.02.2009, 16.04.2010, 19.02.2016 & 07.11.2017 and dealing with the regulation of fee alongwith the subsequent orders issued from DoE from time to time.
4. One more Special Educator shall be engaged within 03 months after issue of order.
5. That school shall make payment of salary and other admissible allowances to its teaching/non-teaching staff as per ongoing CPC through bank/RTGS and comply with the provisions of Section 10(1) read with Rule 125 of DSEAR, 1973.
6. That the school shall abide by the provisions of DSEAR, 1973 and RTE Act, 2009 and observance of orders/directions/instructions issued by the Department from time to time.
7. That the school shall comply with the order/guidelines of DoE & judicial pronouncement w.r.t. safety of students shall take all necessary steps to this effect.


